The Pasco County Purchasing Department will receive sealed bids until **2:00 p.m.**, local time (our clock), on **December 15, 2009**, in the Pasco County Purchasing Department, 8919 Government Drive, New Port Richey, Florida 34654. Bids received after this time will not be accepted. Bids will be publicly opened and read at the above-stated time and date. All interested parties are invited to attend. Bidders shall submit one (1) original of the submitted bid.

The work for Trouble Creek Road Pump Station and 20" Forcemain consists of the construction of approximately 6,800 LF of 20" D.I.P and 2,100 gpm pump station with stand by pump, odor control and telemetry including valves, fittings and appurtenances.

The work for River Crossing Boulevard/Trouble Creek Road/Alico Pass Foremains consists of the construction of approximately 2,075 LF – 12" FM; 965 LF – 12" DIP HDD; 15 LF – 16" DIP FM; 1,800 LF – 20" DIP FM; 650 LF – 20" DIP HDD FM; 3,050 LF – 24" DIP FM; 1,700 LF – 24" DIP HDD FM; 2,360 LF – 30" DIP FM and 1,425 LF – 30" DIP HDD FM.

The estimated cost of the project(s) is \$5,467,430.00.
